

**Facts that Jeremy Dear and NUJ Lawyers do not want NUJ Members to know.**

**Distribution Proviso**

The author and publisher has restricted access to this series of articles to National Union of Journalists (NUJ) and International Federation of Journalists (IFJ) members (also named parties) pending investigation of alleged criminal activity and legal action under: Trade Union and Labour Relations (Consolidation) Act 1992; Solicitors' Code of Conduct 2007; Solicitors Act 1974; Administration of Justice Act 1985; Courts and Legal Services Act 1990; Fraud Act 2006; Employment Equality (Age) Regulations 2006; Vienna Convention on Consular Relations; and, Universal Declaration of Human Rights.

This proviso in no way restricts NUJ and IFJ members from releasing excerpts (with accreditation) to interested third parties including news media. Separate exposés cover unethical and illegal activities by London Freelance Branch officials in a consort with National Executive Council officers.

Independent investigation by law enforcement agencies involves an alleged pattern or practice of joint and several illegal or criminal activities by: National Union of Journalists (NUJ) executives, lawyers, and staff; National Executive Council (NEC) officers; and, London Freelance Branch (LFB) officials.

The author has little personal knowledge of other branches and chapels which do not form part of intended civil and criminal complaints; therefore, he has no opinion on their activities. Adverse comments, all verified and validated to insure accurate reporting, meet legal requirements.

Jeremy Dear, NUJ General Secretary used an *Associated Press* article to illegally derogate with intent to coerce an NUJ member into refraining from demanding his legal rights. It forms part of a campaign of humiliation, degradation, ostracism, and alienation to cover up alleged harassment, incompetence, defamation, and professional misconduct by NUJ officers. Mincoff has repeatedly attempted to delay and deny justice. The email message represents another attempt to harass and intimidate using false and misleading criteria.

Dear conceals the fact that *Associated Press* (AP) and *Seattle-Post-Intelligencer* (PI) published the libelous article from which he took the excerpt in 2002. It covered events that occurred from 1980 onwards. He does not say that the editors at both media organizations received libel complaints soon after publication and that the *Seattle-Post-Intelligencer* managing editor "disappeared" its reporter shortly afterwards. *Associated Press* management did nothing.

The author will refute the excerpted content and admit the article into evidence associated with a pending complaint to Solicitors Regulation Authority (SRA). Neither Dear nor Roy M Mincoff (in-house solicitor) had any right to insist upon justification of academic and professional qualifications from a member neither employed nor requesting employment with NUJ especially when they used as a source an obviously suspect seven-year old news article.

The complaint will name successive NUJ legal officers, with particularity, and other NUJ officials incidentally. [JD-09-0122-1800] [AP-02-0618-0000]

Can you please provide me with copies of your academic qualifications since they seem to be in some question in the attached article.

1. The US Department of Housing and Urban Development investigated many of his claims against Council House and found them baseless, a spokesman said.

*[HUD used willful blindness to ignore elder abuse, namely, three homicides, five unlawful incarcerations, multiple evictions to intimidate witnesses, and jail time for black people who offended the administrator by merely looking cross-eyed at him. Now about 150 tenants live in fear as virtual prisoners in their own flats. Any ethical journalist has a civic responsibility to report crimes of this nature to law enforcement and government authorities. Perceptibly, the Associated Press reporter did not name the "spokesman".]*

2. And Trummel's credibility can be questioned elsewhere. He claims to have been the director of the University Press at the University of Massachusetts in Boston; the school said he briefly advised a student-run project there in the late 1970s or early 1980s.

*[Trummel spent three years as Director of Point Press, a fourth echelon position at the University of Massachusetts/Boston. Staffed with about 20 students who worked and learned typesetting between classes, the press printed materials for university departments and typeset and proofread the campus newspaper. He left the university after state police visited his house and threatened his wife because he had reported the vice chancellor for misusing operating funds allegedly to buy drugs and consorted with student staff who came to work stoned. After a state investigation, the university removed the chancellor from his position for misconduct which may or may not have had a connection to the drug complaint. He then moved to Fitchburg State College (a college in the same system) as Director of the University Press and Assistant Professor.]*

3. Until reminded otherwise, he claims to hold two doctorates — from the University of Washington and Rensselaer Polytechnic Institute in New York.

[Trummel earned doctorates at both universities having completed all formal degree requirements other than the public defense (a formality): denied as retaliation apparently for insisting upon freedom of expression and civil rights in politically sensitive environments. When challenged, administrators falsified university records to support their contentions. He has copies of those records taken before the forgery. The details appear on the web at [\[contracabal.us\]](http://contracabal.us)

4. He was kicked out of a master's degree program at Washington because he did not take the proper courses, prompting him to write a barrage of harassing e-mails to faculty and staff at the university.

*[Trummel taught post-graduate courses in technical and graphic communication at five US universities after completing 25 years as a technical communication executive including a variety of positions as CEO. At one of those universities he received the highest student evaluations in the division and a personal plaudit from a dean much to the chagrin of politically connected professors. He already possessed two masters degrees and had completed two doctorates. So why would he register for a master's course in a discipline in which he excelled professionally for forty years and taught at post-graduate level for more than 25 years?]*

5. The university's public-records officer quit rather than continue dealing with him, said Cheryl.

*[The records officer left in disgust after administrators tried to force her to behave unethically by withholding documents to cover up malfeasance (in an identical way to which Dear and Mincoff silently withhold records). She brought a law suit against the university. University lawyers paid her off and gave her early retirement on the court steps. The records officer had no problem with Trummel. She had many problems with administrators who wanted her to cover up their crimes by withholding records.]*

6. The university's public-records officer quit rather than continue dealing with him, said Cheryl Reid, a spokeswoman for the state Attorney General's Office, which investigated but never brought charges because eventually the harassment stopped.

*[Trummel had a cordial relationship with the records officer. Both the officer and the reporter realized they had an ethical job to perform. He anonymously received important source documents after she retired from the university. Typical of the transference that occurred in this case, Reid has projected the record officer's problems with administrators onto Trummel.]*

7. Though he claims to have been a professor at RPI, he was only a graduate student, and he was fired from an assistant professorship at Fitchburg State College in Massachusetts, the *Post-Intelligencer* reported yesterday.

*[Trummel left Fitchburg State College after three years to complete a PhD at Rensselaer although he held a terminal masters degree which allowed him to teach at post-graduate level.. He taught RPI post-graduate courses at IBM, Kingston, NY after promotion to the adjunct faculty. A libel complaint against Post-Intelligencer awaits their action.]*

*Italicized annotations taken from court records and other documents which support this refutation.*

If Dear had considered the source, then he would have found an orchestrated campaign of character assassination by lawyers in Seattle. If he had properly researched the topic, then he would have found statements concocted after reading a *curriculum vitae* then planting it with a biased *Associated Press* reporter who neither verified nor validated copy before dissemination.

That content matches much of the suborned testimony that Washington Supreme Court threw out as a result of stipulated agreements (30 Mar 06). A reasonable person would assume that the general secretary of a union of journalists that filed *amicus curiae* in a Washington supreme court action, would have at least read the legal briefs.<sup>1</sup>

Doerty ruled that media interviews with willing sources defined as harassment and news gathering constituted unlawful surveillance and stalking. Gullible reporters in Seattle published rants for political expedience instead of contesting the prior restraint and Doerty entered them into evidence.

Seattle lawyers currently have to answer complaints filed against them for professional misconduct and several judges will eventually have to face disciplinary action for gross judicial misconduct before Washington Council for Judicial Conduct. Kirby and Mincoff will soon have to face similar Solicitors' Regulation Authority investigations and proceedings in the UK for their part in the current NUJ fiasco.

The principal attorney who orchestrated the coercion and subornation now awaits a decision by Washington State Bar Association for his professional misconduct in subornation of perjured declarations, one of which he signed himself.

### *Propaganda as Evidence*

A self-styled Maquis de Sade (Felippe Jacques) and lawyers sent 216 different email messages to thousands of people in a defamation campaign then suborned dozens of declarations. Jacques, lawyers, and judges then used Internet blogs to character assassinate dozens of people.

Jacques acted as spokesman for the mafia when he spewed another tissue of lies to Rita Weinstein a *Jewish Transcript* reporter (07 Feb 03). Then, almost unbelievably, lawyers filed a series of perjured declarations in their own client's case based upon the hyperbole.<sup>2</sup>

Donna Gordon Blankinship, a principal propagandist for the Zionist mafia in Seattle, emulates Nazi propagandist Joseph Paul Goebbels. A dogmatic and biased reporter, formerly editor of *The Jewish Transcript*, *Associated Press* later employed her as a stringer. She wrote about the author when he reported suspected terrorists in a tall building also homicide and elder abuse to law enforcement agencies. By that, he ruffled the feathers of a bloody Zionist mafia that owns the building. Its lawyers had him jailed indefinitely without trial.

Blankinship colludes with other Zionist reporters to write propaganda for a mafia responsible for at least three homicides, five unlawful incarcerations, and dozens of unlawful eviction of elderly people predicated upon racial and age discrimination. In ten years neither Blankinship nor any other *Associated Press* reporter has interviewed or telephoned the author for an appointment; instead, they continue to excerpt content from suborned declarations that supreme court stipulated as inadmissible: precisely what Dear did recently for a his propagandist purpose.

Dear picked up *Associated Press* libel with intent to derogate and harass instead of making arrangements to have the matters investigated and prosecuted. Sir Nigel Sheinwald KCMG, British Ambassador to the US has a similar notion and has blocked any FCO investigation into embassy involvement in the case and Dear acquiesces to it.

*Associated Press*, New York has not answered correspondence about the libel that Blankinship and other reporters continue to publish through client news outlets. Rachel Pomerance, *Jewish Telegraphic Agency* wrote at the time: "Indeed, Donna Gordon Blankinship, editor of the *Jewish Transcript* in Seattle, said . . . to accusations that she was anti-Israel. "I am a Zionist," she said, "an ardent Zionist."<sup>3</sup>

With a biased political interest, Blankinship repeatedly disseminated false and misleading information. With her husband Tom, she contributed to Jewish Federation of Seattle which employs directors of the mafia that jailed this author for exposing them.

Blankinship's *Associated Press* report of the Washington Supreme Court finding, which unanimously found for the author (and by extension NUJ and IFJ) exhibited extreme prejudice which later construed as blatantly libelous and warranted a complaint for its obvious bias. Jewish

Federation claims to have a mission to “ensure Jewish survival . . . a vital link to Israel, our tradition, our past and our future” apparently to the detriment of democracy and civil and human rights. [*Without Let or Hindrance*]

Joseph Goebbels described behavior similar to current Zionist behavior and polemics funded by US citizens and demonstrated by the recent incursion and massacre in Gaza. Goebbels wrote: “We enter parliament in order to supply ourselves . . . with its own weapons. . . . If democracy is so stupid as to give us free tickets and salaries for this bear’s work, that is its affair. . . . We do not come as friends, nor even as neutrals. We come as enemies. As the wolf bursts into the flock, so we come”.<sup>4</sup>

Jeremy Dear needs to start checking credentials and motives closer to home for similar polemics that have no place in a democracy and should have even less sway in a trade union. Dear has demonstrated how “a great mass of people will more easily fall victim to a big lie than to a small one”.<sup>5</sup>
