I have repeatedly instructed you to communicate with me by email and PDF attachments in addition to mail. I have explained to you that I frequently travel on assignment and receive mail intermittently. I also asked you not to refer matters to third parties and to respond over your own signature. As you have not complied with any of my instructions or requests for four years, I can only conclude that you have deliberately delayed due process and obstructed justice. By that, you have prejudiced me as your constituent to consort in a conflict of interest among a government minister and National Union of Journalists officers.

Three outstanding issues, which you have not addressed, will become subject to public review and comment:

1. Foreign and Commonwealth Office dereliction in a consort with NUJ which resulted in my illegal jailing in Seattle, Washington.
2. Denial of pension credits and pension (with income now pegged at a total of £35.37/week).
3. Neglect to reimburse EU medical costs.

Therefore, the author gives you notice following the international codes of ethics agreed among journalists. Several of those codes, tested in international courts, have legal precedent. This prepublication notice gives featured individuals a chance to respond to charges affecting their ethics or moral character. People named incidentally receive a copy as a courtesy. For public accountability, the author encourages you to respond in open exchange within ten days. He does not solicit personal opinions, therefore, any response should address matters of fact only.

Non-exclusive excerpts from the publication draft:

1. Gareth R Thomas MP (Harrow West), Parliamentary Under-Secretary of State, Department for International Development (the author's member of parliament) conspired with Jeremy Dear, General Secretary, National Union of Journalist (NUJ) in a cover-up of crimes that alone warrants a public inquiry. The issues relate to dereliction by HM Foreign and Commonwealth Office (FCO) and conspiracy by David C Broom, former HM Consul, Seattle with James A Doerty, a corrupt Seattle judge. FCO and NUJ have, jointly and severally, destroyed or concealed documents in a cover-up of international crimes in which they have complicity.
2. Jeremy Dear, General Secretary, National Union of journalists and Claire S Kirby then NUJ Legal Officer allowed an NUJ member to languish in jail for 111 days of an indeterminate sentence by adopting *laissez faire* policies. Dear has now entered into an illegal composition (construed as a distinct conflict of interest) with Gareth R Thomas MP in an attempt to cover up mutual dereliction and to deprive an NUJ member of due process of law.
3. Thomas allegedly "paid off" Dear not to proceed against the Labour government for dereliction by FCO. Dear and Thomas have for the past two years participated in an illegal cover-up of machination related to grant money which, in the absence of any explanation or access to financial records, classifies as misappropriation of public funds. Dear

has withheld financial records, documents, and disbursement information. FCO has admitted to destruction of comparable records and frustrated access to documents under both US and UK freedom of information statutes.

4. Ongoing investigations by four international Law Enforcement Agencies (LEA) (with another pending) involve criminal violations of statutes. Those investigations also include cyber-terrorism by Internet denial-of-service attacks and illegal computer vandalism by University of Washington (UW); illegal prior restraint by Reginald (Tim) Gopsill; obstruction of justice by Dear and NUJ lawyers; and, malfeasance and denial of due process of law by Gareth Thomas.

An article, published a year ago, provides more detail: [*Without Let or Hindrance*]

The pseudonym *Nmesis* used in *Contra Cabal*, and in other printed and electronic communications, applies to the author's persona. He openly declares personal or conflicting interests that relate to topics or to opinion especially when the content draws upon advocacy, experience, conclusion, or interpretation.

Journalists have a responsibility to gather information and to develop public awareness about wrongdoing by people who break their respective codes of conduct. The author believes that he has a responsibility to bring abuse and wrongdoing to the notice of professional associations and other responsible authorities also to inform law enforcement about malfeasance and misuse of public funds.

Ethical rules dictate that journalists must report the truth no matter whom they offend and with disregard for the consequences of publication. Accurate reporting predicates a higher purpose and the common good.

Targeted individuals initially attacked the author and maliciously damaged him and/or his reputation by libel, slander, or allegedly committed other unlawful or negligent acts. Prior to publication, all targeted subjects have an opportunity to mitigate damage and to refute statements that could negatively affect their reputations or cause investigation or prosecution of them for alleged illegal acts.

No person receives immunity from investigation and the author does not report issues arbitrarily. Individuals whom the author may personally respect receive no favors. In fact, anything published results from investigation, verification, and validation taking into account violations of law or breach of established rules and ethical practices.

Contra Cabal provides a forum in which powerless people may express themselves powerfully without fear of reprisal. They need a means to expose the injustices meted to them by a privileged elite that increasingly usurps authority. *Contra Cabal* also gives them the opportunity to warn others of the frauds perpetrated upon them by corrupt politicians and trade union officers to whom they have granted impunity to support an increasingly anarchic and uncaring government.
